4. Councillor Kern asked if the Green safety clothing was still acceptable to MOL under new changes to regulations; refer this to the Johnson Health and Safety Committee.
5. Tarbutt will investigate how other landfills deal with large quantities of garbage from Schools, is there tipping fees, allowances, Etc.
6. Councillor Wigmore will look into arranging a site visit to MWRC's recycling processing plant in Blind River.
7. The committee requested that the Clerk contact Landfill employees to express appreciation for efforts to make the Johnson – Tarbutt Landfill one of the cleanest and best run Landfills in the area.
8. Committee members also requested the Clerk to speak to Volunteer S. Smith to express their deep gratitude and recognition of her relentless dedication to organizing and overseeing the Share Shed and assisting staff in anyway she can.
