1. You need a fire permit all year long in Johnson Township (They are free and available online).
2. There is NO daytime burning allowed in Johnson Township
3. Be courteous with your smoke and check the wind direction before you light your fire.
4. Read your permit for details on allowable fire size.

### Proof of Identity and Residence

A person voting must present prescribed proof of identity and residence or complete an application in the prescribed form, including a statutory declaration that he or she is the elector shown on the voters' list.

### Voting by Proxy

If you are unable to vote on any of the dates set for voting, you can appoint someone to act as your "proxy." This allows you to appoint another elector to attend the voting place and cast your vote on your behalf. You can obtain a Proxy Voting Application form at the Municipal Office during regular office hours. Proxy's can be certified at the polling stations during the Advance Voting or the Municipal Voting day up until closing.
