Project Description

Contractor to purchase and install Chain-Link (or equivalent) Mesh onto the existing fence framing surrounding the Multi-Sport Court located at the Johnson Township Community Centre, 1 Cameron Drive, Desbarats, ON POR 1EO. Along with the following requirements:

- Fencing is to be 10ft in height and covers a perimeter of 120ft by 110ft or 460ft of Mesh.
- Expansion of gated entrance to 10ft in width. Removal and reinstallation of one fence pole to accommodate width change.
- Provide a new entrance gate with full containment across the width and to the ground.
- Re-installation of 1 Fence Pole.
- Re-installation of 5 top support poles.
- o Re-installation of 6 corner support poles.
- o Replacement of missing caps, wires, and support poles as needed.
