So right now, each of the Council Representatives have to go online and complete a **Criminal Record Check.**

Then go back to your Council and be appointed to the Board.

Once appointed, I will fill out the form: Request for Access to CSPA- Regulated Board Training (attached) for the Ontario Police College (OPC).

Once the form is completed and submitted, each member will be contacted by the OPC and given the information you require to go online and **complete a course**.

Only then will the Board be registered.

Once the Board has been registered – you can have a first meeting!

First meeting would look like this:

Meet and greet with the Detachment Commander Appoint a Chair and Vice-Chair Appoint the Administrative Support Create a schedule for meetings Q & A with Mr. Gervaise (Regional Advisor)

These members are not appointed by the Board, they are selected by the municipalities. So the municipalities must form a Committee to vet the nominees and choose three members for the Board as we currently have 4 nominees (we need 3 Community Representatives).

A pre-requisite for the nominees is also a criminal record check.

Re: Homelessness, Mental Health, Safety and Addiction Crisis

At its Council Meeting of November 5, 2024, the Council of the Corporation of the City of Cambridge passed the following Motion:

WHEREAS the chronic homelessness, mental health, safety and addictions crisis continues to escalate, with at least 1,400 homeless encampments now present in Ontario communities, putting unsustainable pressure on municipalities and public spaces creating a Humanitarian Crisis; and,

WHEREAS housing, homelessness and healthcare - including access to appropriate and timely supports - are the responsibility of the Provincial government and proper management of these issues is crucial to addressing the root causes of the Humanitarian Crisis that Ontario is facing; and,

WHEREAS municipalities are being left to manage these issues without the necessary resources or legal authority to sufficiently respond, and as a result are caught balancing the important needs of unsheltered people living in encampments, with the responsibility to ensure our communities are safe and vibrant places for all residents; and,

WHEREAS the causes of homelessness can be complex and individually unique to each unhoused person, with one of the primary causes being undiagnosed and untreated mental health and addiction issues, which are difficult to address without specialized support systems providing a continuum of care; and,

WHEREAS some individuals experiencing untreated or undiagnosed acute and/or chronic mental health or addictions challenges may be at higher risk to themselves and pose safety concerns for other members of the community; and,

WHEREAS every individual deserves the opportunity for treatment and recovery, including crucial systemic resources, prompt access, and appropriate intervention; and,

WHEREAS Ontario Big City Mayors (OBCM) has launched the SolveTheCrisis.ca campaign to raise awareness of the scale of the humanitarian



crisis in our communities, seek partnerships with the federal and provincial governments to solve it including by: a single responsible Minister and ministry to coordinate action to solve the crisis; an action table with multi-sector stakeholders to create a comprehensive Made in Ontario solution that addresses these issues for all communities in the province; providing municipalities with the tools and resources to transition those in encampments to more appropriate supports; committing to fund the resources required, community by community, to fill existing gaps; invest in a sufficient number of 24/7 community hubs and crisis centres to relieve pressure on hospital emergency departments and first responders and,

WHEREAS the OBCM recommends the consideration of some specific tools and policy asks for municipalities and other sectors involved in this crisis as detailed below; and

WHEREAS an encounter with the criminal court system can be an effective pathway to treatment when the offender is offered a timely and effective treatment referral through a Diversion Court process; and,

WHEREAS the Province's plan to create 19 treatment hubs is a good step and has the potential to substantially improve access to treatment that can be referred through a Diversion Court process if these hubs are properly funded, accessible and expanded in scope and number based on community need; and

WHEREAS the ability of municipalities to ensure safe and vibrant communities is compromised by a double standard in our legal system that allows for the open consumption of illicit drugs but prohibits the unrestricted consumption of tobacco or alcohol, causing confusion and undermining public health efforts; and,

WHEREAS the ability of municipalities to make decisions regarding public safety is compromised by court decisions that enable encampments in public spaces and restrict municipal capacity to manage public lands effectively, including ensuring the safety of the people in those encampments, and the community surrounding them; and,

WHEREAS residents and business owners in neighbourhoods where homeless encampments exist and drug users congregate are unreasonably impacted by social disruption, rising crime, vandalism, and declining public confidence due to concerns for public safety; and,

WHEREAS provincial and federal governments need to take responsibility for policy decisions that have led to this humanitarian crisis and must take on a



greater leadership role in helping municipalities address the associated issues of social disruption and public safety; and,

WHEREAS municipalities need clear, effective and enforceable legislative tools from provincial and federal governments regarding how to address encampments and social disruption, and must have the legal authority to act swiftly and decisively when public safety is at risk; and,

WHEREAS establishing and reinforcing principles and parameters at a provincial level will allow municipalities to focus on what they do best – providing services to members of the public – without the impossible task of reconciling provincial and federal policy or various judicial decisions that are at odds with a group or individual rights; and,

WHEREAS municipal governments must implement solutions that are efficient, effective, appropriate, feasible, practical, and in compliance with Ontario and Canadian law, while balancing individual rights with the safety and well-being of the broader community;

WHEREAS the OBCM has reaffirmed calls to the federal and provincial governments, through its Solve the Crisis Campaign, to:

- i. Appoint one Minister and ministry responsible for the humanitarian crisis Ontarians are facing and who has been provided appropriate authority and resources to find solutions;
- ii. Create an action table of government representatives from all three levels, subject matter experts, and those impacted by this crisis including community partners, first responders and businesses to evaluate solutions to create a Made in Ontario solution; and
- iii. That both levels of government provide the funding required for municipalities big and small to put in place the solutions they need to end this crisis.

WHEREAS the OBCM has strongly requested the provincial and federal governments to:

- i. Take on intervenor status in the case of court decisions that restrict the ability of municipalities to regulate and prohibit encampments; and
- ii. Develop a fully funded and resourced range of compassionate care and treatment programs that strengthens the system of community-based and residential mental health & addictions treatments under the Mental Health



Act and the Health Care Consent Act, ensuring that individuals in need are able to access care and treatment in a timely manner; and

- iii. Urgently review, consult on, and update the Mental Health Act and the Health Care Consent Act to reflect the current realities of this crisis, including consultation with medical professionals, first responders and municipalities to determine whether to expand the scope of and strengthen the existing system of mandatory community-based and residential mental health and addictions care and treatment; and
- iv. Implement Diversion Courts throughout the Province and expand the scope and reach of these courts by permitting referrals to the Diversion Court for Provincial and Municipal Offences, with a focus on rehabilitation rather than punitive measures; and
- v. Review, consult on, and update the Trespass to Property Act to address the public safety issues municipalities are facing within their communities. With such a review to include but not be limited to options to assist communities in addressing aggressive or repetitive trespass ("repetitive trespass"); and
- vi. To establish for municipalities a prescribed provincial priority of maintaining public order and public safety to allow, in line with the above, stronger local deterrents to offenses related to social disruption and public safety risks;

WHEREAS the provincial and federal governments are requested to introduce legislation prohibiting open and public use of illicit drugs and public intoxication, whether that be by consumption of alcohol or illicit drugs, with clear enforcement provisions and public awareness campaigns to reduce the harmful impact on communities.

AND WHEREAS the province has been requested to create a blueprint, along with associated funding programs from both federal and provincial governments, to address the significant need for the quick build of supportive housing units, which includes units that address the specific needs of those who have started treatment and need shelter and care as they continue their recovery journey.

THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the City of Cambridge supports the OBCM motion on chronic homelessness, mental health, safety and addiction crisis;



AND THAT this motion be circulated to Right Honourable Justin Trudeau, Prime Minister of Canada, the Honourable Doug Ford, Premier of Ontario, the Honourable Sylvia Jones, Deputy Premier of Ontario, the Honourable Michael Tibollo, MPP of Ontario, the Honourable Arif Virani, Minister of Justice, the Honourable Doug Downey, Attorney General of Ontario, the Honourable Michael Kerzner, Solicitor General of Ontario, the Honourable Mark Holland, Federal Minister of Health, the Honourable Paul Calandra, Minister of Municipal Affairs and Housing, Laurie LeBlanc, Deputy Minister of Municipal Affairs and Housing, Rebecca Bligh, Federation of Canadian Municipalities President, Robin Jones, Association of Municipalities of Ontario President, and all Ontario Municipalities.



Too many Ontarians are being seriously injured or killed on our roads.

In 2023, there were 616 people killed and 36,090 people injured. The number of fatalities is up nearly 20% in the last ten years.

In 2021, the most recent year of complete data from MTO's Ontario Road Safety Annual Report (ORSAR), there were 561 fatalities – 426 of which occurred on municipal roads. While rural Ontario only represents 17% of the province's population, 55% of these deaths occurred on rural roads. By any measure, Ontario's rural roads are disproportionately more dangerous.

At the same time, municipal insurance premiums continue to increase. With no plausible reform being considered for joint and several liability, municipalities need to find innovative means for managing risk, particularly on their roadways,

To deal with this crisis, Good Roads has designed a multifaceted rural road safety program and have been in discussions with the Ministry of Transportation to fund it. The program would target a municipality's most dangerous roads, perform road safety audits, and install modern safety infrastructure that prevents serious injuries and save lives. This program is designed to be cost effective while also providing rural municipalities with a direct means for addressing risk associated with their roadways.

Good Roads has proposed leading a five-year \$183 million program that leverages our 131 years of municipal road expertise and our industry partnerships to quickly put in place the solutions that will address some of Ontario's most dangerous roads.

Good Roads is seeking support to address these preventable tragedies.

If the Township of Johnson would be interested in pursuing this, a Council resolution similar to the example below should be adopted and sent to the Premier and the Minister of Transportation:

WHEREAS official statistics from the Government of Ontario confirm that rural roads are inherently more dangerous than other roads;

AND WHEREAS, despite only having 17% of the population, 55% of the road fatalities occur on rural roads;

AND WHEREAS, rural, northern, and remote municipalities are fiscally strained by maintaining extensive road networks on a smaller tax base;

AND WHEREAS, preventing crashes reduces the burden on Ontario's already strained rural strained health care system;

AND WHEREAS, roadway collisions and associated lawsuits are significant factors in runaway municipal insurance premiums. Preventing crashes can have a significant impact in improving municipal risk profiles;

THEREFORE, BE IT RESOLVED THAT the Township of Johnson requests that the Government of Ontario take action to implement the rural road safety program that Good Roads has committed to lead. It will allow Ontario's rural municipalities to make the critical investments needed to reduce the high number of people being killed and seriously injured on Ontario's rural roads; and

FURTHER THAT a copy of this resolution be forwarded to Premier Doug Ford, Hon. Prabmeet Sarkaria, Minister of Transportation, Hon. King Surma, Minister of Infrastructure, Hon. Rob Flack, Minister of Agriculture, Hon. Lisa Thompson, Minister of Rural Affairs, Hon. Trevor Jones, Associate Minister of Emergency Preparedness and Response, and Hon. Sylvia Jones, Minister of Health, and Good Roads; and

FURTHER THAT this resolution be circulated to all municipalities in Ontario requesting their support.

RE: Concerns with the Transport and Deposition of Naturally Occurring Radioactive Material (NORM) at the Agnew Lake Tailings Management Area (ALTMA)

Dear Premier Ford,

I am writing to you on behalf of the Council of the Township of Nairn and Hyman and the Council of the Township of Baldwin to formally submit the attached resolution passed jointly by the two Councils at a Joint Emergency Council Meeting on August 19, 2024.

Our two Townships very recently learned of the decision to transport naturally occurring radioactive material (NORM) from the former Beaucage Mine Site and Nipissing First Nation reserve lands and deposit it at the Agnew Lake Tailings Management Area in the Township of Nairn and Hyman. The decision to transport and deposit NORM has far-reaching implications for the environment, public health, and safety of our communities, and this significant decision was made without any consultation with our municipalities and the other municipalities located near Agnew Lake or along the Highway 17 corridor.

In addition to the participation of our municipalities in this Emergency Council Meeting, many representatives from surrounding First Nations attended the meeting, underscoring the widespread concern across our region about this impending project. The planned transportation of NORM is scheduled to begin in the coming weeks, therefore we respectfully request your attention to this urgent matter.

The resolution reads as follows:

RESOLUTION: 2024-EM1-2 DATE: August 19, 2024

MOVED BY: Councillor McVey SECONDED BY: Councillor Cote

WHEREAS the Council of the Corporation of the Township of Nairn and Hyman and the Council of the Corporation the Township of Baldwin have been informed of the decision to transport naturally occurring radioactive material (NORM) from the former Beaucage Mine and Nipissing First Nation reserve land, and deposit it at the Agnew Lake Tailings Management Area (ALTMA) in the Township of Nairn and Hyman; and

WHEREAS this decision has significant implications for the environment, public health, and safety of the surrounding communities, including those within the Township of Nairn and Hyman and the Township of Baldwin; and

WHEREAS the decision to transport and deposit NORM to the ALTMA site was made without any consultation with the Township of Nairn and Hyman or the other municipalities bordering Agnew Lake, resulting in the exclusion of local municipalities from the decision-making process; and

WHEREAS the exclusion of local municipalities from this process represents a serious breach of trust and a disregard for the well-being of the residents of these communities; and

WHEREAS there are significant concerns among residents regarding the potential contamination of drinking water sources, particularly Agnew Lake, which many residents rely on for safe drinking water; and

WHEREAS the risks associated with NORM are well-documented, and the proximity of the ALTMA to Agnew Lake heightens the concerns regarding the potential contamination of this vital water source; and

WHEREAS according to information received from the Ministry of Mines, there are already some areas of the ALTMA site where dose estimates exceed the Canadian Nuclear Safety Commission's regulatory limit for casual site users; and

WHEREAS the Council of the Corporation of the Township of Nairn and Hyman and the Council of the Corporation of the Township of Baldwin held a joint Emergency Council Meeting on August 19, 2024;

THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Township of Nairn and Hyman and the Council of the Corporation of the Township of Baldwin respectfully demands that the Province of Ontario, the Ministry of Mines and the Ministry of Transportation immediately halt the project involving the transportation and deposition of NORM at the ALTMA site until a clear line of communication is established with local municipalities; and

BE IT FURTHER RESOLVED THAT the Council of the Corporation of the Township of Nairn and Hyman and the Council of the Corporation of the Township of Baldwin respectfully demands full disclosure of all pertinent details regarding the proposed future NORM transportation and deposition plan, including specific transportation routes, emergency response plans, safety protocols, and the future management plan for the ALTMA site; and

THAT the Council of the Corporation of the Township of Nairn and Hyman and the Council of the Corporation of the Township of Baldwin insists that environmental and health impact assessments be conducted with input from independent experts, and that these assessments include opportunities for public hearings to ensure transparency and community involvement; and

THAT the Province of Ontario enact legislation that consultation with municipalities is a requirement of any projects that include the transportation or deposition of NORM; and

THAT a copy of this resolution be forwarded to the Honourable Doug Ford, Premier of Ontario; the Honourable George Pirie, the Minister of Mines; the Honourable Prabmeet Sarkaria, the Minister of Transportation; the Honourable Andrea Khanjin, the Minister of the Environment, Conservation and Parks; Chief Toulouse and Sagamok Anishnawbek Council Members; Chief Nootchtai and Atikameksheng Anishnawbek Council Members; the Ontario Ombudsman; the Canadian Nuclear Safety Commission; the Canadian Environmental Law Association; MP Carol Hughes; MPP Michael Mantha; the Association of Ontario Municipalities and all Ontario Municipalities.

WHEREAS it is apparent that the Ontario Government has overlooked the needs of small rural Ontario; AND

WHEREAS Ontario's small rural municipalities face insurmountable challenges to fund both upfront investments and ongoing maintenance of their capital assets including roads, bridges, water/ wastewater and municipally owned buildings including recreational facilities, libraries and other tangible capital assets:

AND WHEREAS small rural Ontario's operating needs consume the majority of property tax revenue sources; AND WHEREAS small rural municipalities (of 10,000 people or less) are facing monumental infrastructure deficits that cannot be adequately addressed through property tax revenue alone; *AND

WHEREAS in 2015 the provincial government moved to standardized billing for all non-contract D.P.P. (5.1) locations; AND WHEREAS the Ontario Government has committed \$9.1 billion to Toronto alone to assist with operating deficits and the repatriation of the Don Valley and Gardner Expressway; and \$534 million to Ottawa for the repatriation of Hwy 174; AND WHEREAS the annual cost of the Ontario Provincial Police, Municipal Policing Bureau for small rural non-contract (5.1) municipalities is approximately \$428 million;

AND WHEREAS this annual cost is significantly less than the repatriation costs of the Gardiner Express Way, the Don Valley Parkway and Highway 174 (Ottawa Region) but provides a greater impact to the residents of the Province overall; AND WHEREAS this will afford relief to small rural municipalities for both infrastructure and operating needs while having a minimal impact on the provincial budget; NOW

THEREFORE BE IT RESOLVED THAT The Municipality of Tweed call on the Ontario Government to immediately implement sustainable funding for small rural municipalities by reabsorbing the cost of the Ontario Provincial Police Force back into the provincial budget with no cost recovery to municipalities:

Further to our telephone discussion and email, a recent survey of the driveway constructed to access the Thorncamp cottage property reveal that it has inadvertently encroached over part of the shoulder owned by the Township near its water treatment plant. From the plan attached to this letter, the encroachment is coloured red.

When the road was constructed it was believed that it was entirely on land owned by Kensington Point Marina to the immediate south of their storage buildings on the west side of the pubic road. The current location of the driveway has truly been the only spot where Thorncamp could build a driveway and provide the owners with access.

The attached plan erroneously shows the Township's part 1 1R7255 as forming part of the Phillips property. I have confirmed with you that the Township's property (outlined in blue) is indeed a separate parcel. I have requested that the plan be amended to correct this error. The new plan will be forwarded to you upon receipt.

On behalf of Thorncamp Inc. I am requesting that the Township grant a licence to my client to encroach upon the corner of the property (shown in red) solely for the purpose of continuing the existence of its private driveway.

I will be submitting an application to sever and purchase the driveway from the marina property to the south boundary of lots 42 and the related zoning amendment to permit the purchased parcel to become a lot addition to the Thorncamp lands to the immediate west which show on the plan as PIN 31457-0556.

By-law 2024-1124

Emergency Management Program and Emergency Response Plan By-law

A By-law to adopt an Emergency Management Program and Emergency Response Plan and to meet other Requirements under the Emergency Management and Civil Protection Act

WHEREAS under the Emergency Management and Civil Protection Act, R.S.O. 1990, c. E.9 and (the "Act") Ontario Regulation 380/04 (the "Reg") every municipality in the Province of Ontario is required to:

- Develop and implement an emergency management program, which shall consist of:
 - o an emergency plan;
 - o training programs and exercises for employees of the municipality and other persons with respect to the provision of necessary services and the procedures to be followed in emergency response and recovery activities;
 - o public education on risks to public safety and on public preparedness for emergencies; and
 - o any other elements required by the standards for emergency management set under the Act or by Emergency Management Ontario;
- . Designate an employee of the municipality or a member of the council as its emergency management program coordinator;
- o Establish an emergency management program committee;
- . Establish an emergency control group;
- Establish an emergency operations centre to be used by the municipal emergency control group in an emergency; and
- . Designate an employee of the municipality as its emergency information officer;

AND WHEREAS it is prudent that the emergency management program developed under the Act be in accordance with international best practices, including the five core components of emergency management; prevention, mitigation, preparedness, response and recovery;

AND WHEREAS the purpose of such a program is to help protect public safety, public health, the environment, critical infrastructure and properly during an emergency and to promote economic stability and a disaster resilient community;

NOW THEREFORE the Council of the Corporation of the Township of Johnson hereby enacts as follows:

Rob Romberg and Janet Maguire are hereby appointed as alternate CEMCs to act in place of the primary CEMC in his/her absence.

Emergency Management Program Committee

- B The persons holding the following positions in the municipality shall be members of the Emergency Management Program Committee:
 - a. Chief Administrative Officer (CAO)
 - b CEMC
 - c. Director of Finance/Treasurer
 - d. Director of Health and safety
 - e. Fire Chief
 - f. Deputy Clerk
 - g Head of Council (Mayor)
 - h. Public works superintendent
- The CAO is hereby appointed as chair of the Emergency Management Program Committee.
- 10. The Emergency Management Program Committee shall advise Council on the development and implementation of the municipality's Emergency Management Program and shall review the program annually.

Municipal Emergency Control Group

- 11. The persons holding the following positions in the municipality shall be members of the Municipal Emergency Control Group (MECG):
 - a· Head of Council Mayor
 - b Emergency Operations Centre Director Chief Administrative Officer
 - Emergency Information Officer Treasurer
 - d Liaison Officer Clerk/CAO
 - Recording Clerk Deputy Clerk
 - Operations Section Chief Fire Chief/ public works
 - f. Planning Section Chief Council member

Emergéncy Operations Centre

12. A primary and an alternate Emergency Operations Centre have been established for use by the MECG in an emergency and with the appropriate technological and telecommunications systems to ensure effective communication in an emergency. The locations of the Emergency Operations Centres are identified in an annex to the Plan.

Emergency Information Officer

Emergency Management Program

- An Emergency Management Program for the municipality will be developed and reviewed annually by the Emergency Management program Committee consistent with and in accordance with the Act, the Reg, and international best practices, including the five components of emergency management, namely: prevention, mitigation, preparedness, response and recovery, and such program shall include:
 - a training programs and exercises for employees of the municipality and other persons with respect to the provision of necessary services and the procedures to be followed in emergency response and recovery activities;
 - b public education on risks to public safety and on public preparedness for emergencies; and
 - any other elements required by the standards for emergency management set under the Act or by Emergency Management Ontario.
- The Emergency Management Program shall be consistent with the objectives of protecting public safety, public health, the environment, critical infrastricture and propefiy, and to promote economic stability and a disaster-resilient community.

Emergency Response Plan

- The Emergency Response Plan, which has been developed in accordance with the requirements of the Act and Reg and international best practices, and which is attached hereto as schedule A is hereby adopted (the "plan"),
- The Plan shall be reviewed annually by the CEMC and the Emergency Management Program committee. The CEMC is authorized to make such administrative changes to the Plan as appropriate to keep the plan current, such as personnel, organizational and contact information updates. Any significant revision to the body of the plan shall be presented to council for approval.
- When an emergency exists but has not yet been declared to exist, employees and the Emergency Control Group may take such action under the plan as may be required to protect properly and the health, safety and welfare of the inhabitants of Township of Johnson.

Community Emergency Management Coordinator

Jason Kern, is hereby appointed as the primary community emergency management coordinator (the "CEMC,,) responsible for the emergency management program for the Town including maintenance of the Plan, training, exercises, public education and such other duties and responsibilities as ouilined in the Act.

The Town's communications officer is hereby appointed as the Emergency Information Officer for the municipality to act as the primary media and public contact for the municipality in an emergency.

Administration

The Plan shall be made available to the public for inspection and copying at the Township office, 1 Johnson Drive during regurar business hours.

The Plan, or any amendments to the Plan, shall be submitted to the Office of the Fire Marshal and Emergency Management as identified in the Act.



Fall 2024 Managed Forest Tax Incentive ALUS Farm Conservation Freshwater Jellyfish





The Managed Forest Tax Incentive Program (MFTIP)

The MFTIP is an excellent program that enables qualified woodlot owners to save 75% of their taxes on the wooded proportion of their property. In return, landowners promise to manage their woodlots sustainably, develop a set of objectives (such as trails, protect and maintain the woodlot, etc.) and can harvest timber using Good Forestry Program guidelines. In Ontario approximately 10% of all forested woodlots are in private ownership leaving 90% of private lands NOT enrolled in the MFTIP.

A MFTIP stewardship Plan extends for a period of 10 years. A new plan must be submitted before June 30th of each year to qualify for the following years' taxation. After five years a landowner must submit a record of work completed in the woodlot according to the Plan to stay enrolled in the program. After ten years a new updated plan must be written to continue enrolment.

To be eligible for a MFTIP the following criteria must be met:

-property is in Ontario.

-owned by a Canadian citizen or permanent resident, a Canadian corporation, partnership or trust or a conservation authority.

-the woodlot must be at least 9.88 acres in area excluding buildings or residence. -must include a minimum number of trees on each acre.

MFTIP Stewardship Plans help landowners learn and to appreciate the economic, aesthetic and environmental values of their woodlot. In addition, MFTIPs help to preserve woodlands for future generations, protect critical habitat and food sources for Species at Risk and other wildlife as well as protect riparian resources, air and water quality.

In addition to MFTIPs there is a similar program called Conservation Land Tax Incentive Program which provides a 100% property tax exemption for people willing to not utilize their forested land other than for passive uses; does not allow timber cutting (except for minimal personal usage). Program must be reapplied for each year.

Voluntary Farm Conservation Initiatives Alternative Land Use Services (ALUS)

Central Algoma - Warm Autumn Lake Water Freshwater Jellyfish - Craspedacusta sowerbii

With the warm autumn lake water Central Algoma cottagers have been reporting the floating medusa stage of Freshwater Jellyfish in this fall. Freshwater Jellyfish is not native to Canada and is an invasive species. The jellyfish consume zooplankton and are a concern. Their tentacles sting and paralyze zooplankton but are not capable of piercing mammal skin.



Invasive species are a real problem in Canada, and one species in particular, the freshwater jellyfish species of the genus Craspedacusta sowerbii — C. sowerbii, or the Peach Blossom Jellyfish — are as widespread as they are also poorly understood.

There is anecdotal evidence that the invasive jellyfish had been present in British Columbia lakes and ponds for decades. Still, compiled data suggest that the number of sightings has increased considerably since the year 2000.

Unfortunately, however, we still have very limited information about the range of its presence in Canada, how it got here, how it spreads and what its essential impact on freshwater ecosystems across Canada may be. No mitigation and management strategy has yet been developed and many fundamental questions about the species ecology are unanswered.

Climate change and species introductions

The Craspedacusta species is a subtropical but adaptable organism which favours moderate- to high-water temperatures. While cold water temperatures have acted as a historical check on their growth and expansion, warming temperatures around the globe are helping to expand their territory.

Recent increases in sightings of C. sowerbii in B.C., across Canada and worldwide are therefore indicative of an expanding suitable habitat for the jellyfish as a result of global warming, alongside a growing public awareness and increased observational efforts leading to more effective recognition.

Current modelling shows that the Peach Blossom Jellyfish will expand to ever higher latitudes in both hemispheres over this century and be present in freshwater systems longer in the year from spring to late autumn.

Unfortunately, the species has rarely been the focus of research. Currently, as far as I am aware, only biological oceanographer Evgeny Pakhomov and I are now researching the species and its significance for Canada.

Our research shows that this trend is not restricted to B.C. but is expected to happen in other provinces such as Alberta, Ontario and Québec too. Craspedacusta sowerbii irregularly occurs in the Great Lakes area on both sides of the Canada-United States border since the 1930s.

Small invader, unpredictable occurrence

The current state of provincial monitoring and reporting on this species is, unfortunately, lacklustre.

While a number of tools and data have been shown to be effective in monitoring populations in North America and Europe, no province currently includes these in annual reports and statistics.

For example, the Invasive Species Council of British Columbia's annual report does not conduct large-scale data synthesis on the Peach Blossom Jellyfish. As a result of this lack of data, no evidence of seasonal or long-term population trends exists.

Compounding these difficulties is the fact that the C. sowerbii is known as a species complex, meaning that there are likely several species going undetected under the same name. The nuances of these species distinctions are not only of academic interest, but also hold the key to identifying how these species move across and between ecosystems.

Understanding all of these aspects is crucial for us to start seriously thinking about mitigation and management strategies.

We cannot manage what we don't understand

While the species is harmless to humans, it is unknown how the freshwater jellyfish interact with other lake and pond inhabitants. There is evidence that these jellyfish are a potentially rich source of food for juvenile fish and they could compete with other native species as food.

Meanwhile, not enough up-to-date information is available about the various life stages of the jellyfish and the particular impacts of each stage. Indeed, while polyps and other juvenile stages are present year-round, their exact locations, abundance and activity levels are entirely unknown.

While governmental reporting infrastructure does exist in some provinces and territories, large-scale data have not yet been analyzed. Efforts are hampered by

the lack of inclusion of the Peach Blossom Jellyfish in regular monitoring programs.

We hope to stimulate interest and motivation to better understand this problem at all levels from federal to provincial governments and local municipalities.

This lack of data, and effort by provinces to collect them, has serious consequences for Canada's ecological security and limits the effectiveness of any management or adaptation plan in the years to come.

As winter approaches, municipalities and public works roads crews are preparing for increased road maintenance and severe weather events.

A newly constructed sand dome in the Township of Johnson, funded in-part by the Canada Community-Building Fund, will provide crews quick access to sand and salt when a winter storm hits.

In years past, the Township purchased sand from an off-site Ministry of Transportation location. This meant crews had to travel almost an hour roundtrip to fill their trucks before tending to icy or snowy roads. This travel time, combined with rising costs to purchase the sand on contract with the MTO, prompted the Township to look at alternatives.

In 2024, the Township invested CCBF funding into the construction of a 72 by 120 foot Calhoun sand dome with a cement pad. The dome provides more than enough space to house the 1,000 tonnes of sand and salt used every winter season and is located on-site at the public works garage. Now, crews can load up with sand in less than 10 minutes and be on their way to take care of winter road maintenance.

Aside from saving time, Township staff estimate they save around \$25,000 in material costs alone — with more savings to be found in equipment wear and tear and fuel costs. Additionally, the new dome has made it easier to predict an annual sand and salt budget. The municipality places a single order for sand and salt, rather than paying individual invoices for trips made to an off-site dome.

The Township completed this project just in time for the 2024 winter season.

So to answer a few have you questions, the Township has always purchased their sand from MTO and when MTO privatized it's been a few different contractors and is Ledcor now. I have been with the Township for five years now my first winter I put up a little bit of sand just here in the yard and purchased some from our local MTO yard now that there's private contractors, The price of sand has really climbed for the first 500 tonne. It is \$50 a yard After 500 it jumps up to \$58 a tonne We go through about 1000 tonne a winter. we save over 25,000 a year by putting up our own sand. That is material only there's no wages fuel and wear and tear on the truck included in that.

The sand dorm is 20 minutes away so by the time you get loaded and come back, you're gone the better part of one hour, so when it is a freezing rain event, you can never get ahead of the ice. With the sand right on site in our Township we are 10 minutes and back on the road

It definitely is much easier for staff as far as scale, tickets, and the amount of sand we purchase from an outside contractor when it's here in the yard, we get one bill for sand and one bill for salt
