

## Minutes of the Regular Meeting June 18, 2025 1 Johnson Drive, Desbarats

The following minutes are comprised of resolutions and the Clerk's interpretation of the meeting. The meeting was called to order at 6:00 PM.

BE IT RESOLVED THAT COUNCIL called the regular meeting to order at 6:00pm. (cd)

Veronica Alimole was in attendance to discuss the lack of organized Economic Development Plan within the Township of Johnson. Assistance with navigating Township By-laws, updating township by-laws to be more conducive to development, and municipal support with locating funding opportunities for small businesses were discussion points.

Council will explore the creation of an economic development committee within Johnson Township. Mayor McKinnon thanked Mrs. Alimole for her attendance.

Staff members provided additional information regarding their reports. In addition to the Recreation Coordinator's report, an additional proposal regarding the Margaret Street property was included, proposing that some or all of the property 3.3 acre parcel be retained for recreation purposes. Currently, the arena property is 7.57 acres, a portion of the school property is 6.56 acres and the portion that the municipality is making available for development is 3.3 acres.

The 2025 Water and Sewer Rate by-laws were presented for adoption.

Council received the Staff Report regarding the extension of the Franchise Agreement with Enbridge Gas Inc. This agreement expires in November, 2025. It is recommended that Council provide the Clerk/CAO (or alternate) and Mayor the authority to execute this agreement, using the approved model.

franchise agreement pertaining to the Corporation of the Township of Johnson is not necessary pursuant to the provisions of Section 9(4) of the *Municipal Franchises Act*. (c)
